

Resources for Becoming Trauma-Informed in Response to the COVID-19 Pandemic (Updated: September 13, 2020)

With the four initial laws that Congress has passed to begin the nation's response to the pandemic, there is an opening to influence the direction of flexible, federal funding toward trauma-informed approaches and building resiliency. While none of the laws specifically direct funds toward trauma-informed approaches, there are provisions that reference "mental health" and "social-emotional" supports. With guidance and leadership from trauma and resilience advocates, decision makers could choose to direct funds to making many or all public systems trauma-informed and hope-building.
